#### **About Our 2025 Annual Meeting**

2024 was again a year of change. This year's annual meeting will be similar to last year's and will continue to adjust and evolve. We will be holding our annual meeting on the third Sunday of January as per our bylaws, but...

- With the advance of technology and mindful of the health protocols still considered for the sake of our community, we will again have a virtual option in addition to the inperson Annual Meeting this year. The Zoom option of our Annual Meeting is only open to voting members in good standing according to the criterion laid out in our congregation's constitution and bylaws. Guests and visitors are not permitted to attend the meeting virtually.
- As the rules and needs dictate, **voting** will be by voice, hand, and electronic poll, as ballots as-we-know-them cannot be done in a virtual meeting. If the need for a ballot vote arises, only those present in-person will have opportunity to vote via ballot. **Quorum needed for the meeting this year is 40.**
- The 2025 Proposed Budget is available through our church office the week before the annual meeting. Stop in and pick up a hard copy from our Office Administrator during regular business hours.
- What does it mean to be a "voting member in good standing?" According to our constitution (C8.02.c), a voting member is a confirmed member. "Such confirmed members, during the current or preceding calendar year, shall have communed in this congregation and shall have made a contribution of record to this congregation. Members of this congregation who have satisfied these basic standards shall have the privilege of voice and vote at every regular and special meeting of the congregation as well as other rights and privileges ascribed to voting members by the provisions of this constitution and its bylaws." Basically, if you are a confirmed member of this congregation and we have records that show that you have attended worship either in person or virtually in 2024 or 2025, and we have records that show that you have given offering at some point in that same timeframe, you are a voting member and have all of the rights and privileges therein.
- If you have any questions on any of the reports, agenda, points of order, or the budget, we are asking that you get them to the congregation president ahead of time by emailing them at <a href="mailto:president@stjohnserie.org">president@stjohnserie.org</a> if at all possible. ## **Annual Meeting of the Congregation January 21, 2024 Official Minutes**

**Call to order** at 11:20am. by Roger Olsen, Council President.

A quorum was confirmed with 39 members attending.

Blessings and opening prayer was offered by Pastor Jerry Gray.

#### **Dufford Terrace Report:**

The meeting was turned over to Beth Nagy, President of Dufford Terrace Board to present their Annual Report. Beth thanked the congregation for their attendance at the special meetings in order to have new by-laws passed. Beth shared highlights of the report and noted Dufford Terrace is continuing to upgrade apartments with new carpeting and flooring and walk-in showers.

A motion was made by Sue Carlson, 2nd by Pam Gildersleeve to accept the Minutes from the Annual Congregational Meeting held January 22, 2023. Motion carried.

#### **Congregational Elections:**

- Church Council: There are eight open positions. Roger Olsen and Max Matthew Alwens were nominated to serve two of three positions for a three year term; Carolyn Sturtevant, Janet Heubel, and Marj Quinn were each nominated to serve two year terms; and Mark Eller was nominated to serve the one year term position. All nominees were elected by unanimous ballot. Two positions remain open for three year terms.
- Youth Member of Council: There were no nominations for this position. Position will remain open until a suitable and willing candidate can be found to fill the position.
- **Dufford Terrace Board:** There are four open positions. Tim Durst, Barb Kulisek, Paul Rapela, and Bob Schlaufman were each nominated for three year terms. All nominees were elected by unanimous ballot.
- Bahm/Palmer Committee: There are two open positions for three year term and one open position for a two year term. David Haffley and Shantel Kay were nominated to serve for the three year term and Nancy Durst was nominated for the two year term. All nominees were elected by unanimous ballot.
- **Synod Assembly:** Butch Karnes and Carolyn Sturtevant were nominated to serve as our delegates. Nominees were elected by unanimous ballot.
- **Nominating Committee:** There were no nominations for this committee. Outgoing council members will fill open positions.
- Audit Committee: There are three positions open. There were no nominees.

Motion was made by Audrey Boam and 2nd by Julie

Zoumbaris to accept the ballot for all positions. Motion carried. Ballots collected. Results recorded above.

#### **Reports:**

Investment Report: Tim Durst present the Finance/ Treasurers' report. Tim reviewed balances in the accounts, noting that there are dedicated funds in our main checking account (which means they can only be used for specific purposes). Money from these dedicated funds were transferred to a Money Market Account so they will earn interest. Accounts were also set up within the Money Market to record offsets for each. Our unrestricted account only used \$20,000.00; which was actually expenses for 2022. We are in a relatively safe financial position.

Questions: Can Memorial Fund monies be used for general expenses? Answer, Yes, council can determine what it is used for. Lighting Fund, it is a dedicated account..

**Budget:** Tim reviewed some changes to the budget. Income: Investment income increased, due to movement of dedicated funds to Money Market accounts rather than in checking account. Expenses: Salary increases for staff, nothing budgeted for Pastors Salary, Synod benevolence decreased due to anticipated decrease in giving (20% of current envelope). Expense for Waldameer, donated by

Questions: What was Special Projects money used for in 2023? Answer: for an A/C and heat unit for the Chapel. Roger Olsen also noted we need to replace the boilers, discussion followed. A motion was made by Roger Olsen, 2nd by Butch Karnes to move \$20,000.00 from Capital Appeal Fund to replace the boilers. Motion defeated. Discussion: The motion was amended by Roger and 2nd by Butch to move no more than \$25,000.00 from Capital Appeal funds to replace the boilers. Motion carried.

A motion was made by Butch Karnes properly seconded by John Durst to accept the amended budget. Motion carried.

There were no questions on the written reports of the committees. Motion by Scot Zoumbaris, 2nd by Carolyn Sturtevant to accept all committee reports.

**Old Business:** From our special meeting on February 26, 2023, Motion to amend our constitution C10.04 to read: Forty (40) percent of the voting members or 30 members, whichever is greater shall constitute a quorum. This motion was voted on and carried, ratification to occur at the next congregational meeting. A vote was taken on the motion to ratify the amendment to the constitution. Motion carried.

New Business: Call Process: Discussion of the status of the church and a call process. Sadly even if we were ready to call a Pastor there are few available. There are currently 21 churches in our synod without Pastors, some have a shared Pastor or Deacon, or shared part-time Pastor. Any start to calling a Pastor will have to begin with the Bishop. We are grateful for the Supply Pastors who have kept our congregation worshiping during the past year and look forward to continued support from the congregation as we navigate this next year and perhaps further until a call can be made. We will need to have a transition team with 2 members of council plus other members of the congregation. Beth Nagy volunteered to serve on a Transition Team.

### Installation of Church council members will be on January 28th.

#### **Music Director and Organist-2024**

The goal of the music program of St. John's is to glorify God and to enhance the worship experience of the congregation. It is important to have worship music integrated into the total life of the Parish.

Throughout the year, it is my responsibility to select

and play the organ preludes, offertories, hymns, communion music and postludes for all services, Holy Days and extra worship such as during Advent and Lent. In 2024, I played for all the mid-week Lenten services. All music is selected to correspond with the Lutheran liturgical calendar.

The Chancel Choir and Bell Choir have played throughout 2024. They sing and ring for the 10:00 AM services and special Holy Day services beginning in September and ending in June. The choirs practice every Sunday under my direction. Several new members have joined the Chancel Choir. In August, new music was selected and ordered for the Chancel and Bell choirs. Also, postcards were sent to perspective members to help increase participation in the choirs. Members of the Chancel Choir are Carolyn Sturtevant, Marj Quinn, Arline Janel Anderson, Connie Leretsis, Watson. Gildersleeve, Bob Bestvina, Mark Eller and Pastor Mineo. Members of the Bell Choir are Janel Anderson, Carolyn Sturtevant, Bill Kay and Mark Eller. I would like to thank the choir members for their dedication and service to the Lord and St. John's.

One of the duties of my position is to rehearse all cantors, soloists and instrumentalists. Besides the choirs, many special musicians have played in 2024. Among them have been Janel Anderson on the flute, brass instrumentalists from the Gem City Band, alto saxophonist Tim Powell, and Pastor Mineo with the guitar. Nolan Durst has provided music on the piano/keyboard for several of our services. The Stained Glass Ensemble consisting of flutes, clarinets and keyboard/organ played several times in 2024. Members of the Stained Glass Ensemble are Janel Anderson, Carolyn Sturtevant, Bill Kay, and Mark Eller. It is planned to have them return in 2025.

Carolyn Sturtevant has served faithfully as our Cantor every Sunday. I would like to thank Carolyn for her outstanding dedication and service to St. John's.

In coordination with the Pastor, I select hymns for the 10:00 AM services and Holy Days. During the summer months, the congregation enjoys selecting favorite hymns that are included in the 10:00 AM service. For copyright protection, we belong to an organization entitled One License. Choir anthems, prelude and postlude music have to be reported to One License for copyright protection. Any music that has been published within the last 70 years has to be reported to One License. I have been researching proper copyright procedures and attending virtual copyright workshops to help ensure compliance with the law.

It is my responsibility to maintain all musical instruments and keep the organ and pianos in repair and in tune. This was continued throughout 2024. In addition to the pianos in the Sanctuary, pianos in the Assembly Room, Choir Room and Fellowship Hall (gym) were, also, maintained. St. John's organ is a valuable and historical instrument. It is important to keep it in good working

condition. Besides the necessary tunings, work was done on the static reservoir to increase the pressure in the instrument. Further specialized maintenance will be done in 2025.

We have increased the use of our keyboard in 2024 and have even used it for entire services. The keyboard is available for use in combination with special soloists and different ensembles for the worship services.

On August 11, St. John's hosted Bishop Lozano. Besides the organ, special music was provided by Janel Anderson on the flute and The Stained Glass Ensemble.

I attend and participate in the Worship and Music Committee meetings once a month. The Worship and Music Committee meetings are an important part of planning and keeping communications lines open within our Church community.

To maintain my professional skills and contacts, I am an active member of the Erie Chapter of the American Guild of Organists and a long-time Board member and Secretary of the local Chapter. I am a member of the Erie Music Teachers' Association, the Association of Lutheran Church Musicians, and the Church Music Institute. These organizations have helped provide valuable information through publications, workshops and webinars that assist in conducting our Church music program. Through my memberships in these various musical organizations and, as part of my continuing education, I have attended several webinars and workshops virtually in 2024:

Also, maintenance work on the pipe organ has begun that will continue into 2025. I have continued to work on is the inventory and organization of the large volume of organ and bell choir music that has accumulated from previous directors. This is important to determine which music is outdated and to determine what new music needs to be purchased. The increase in numbers in the Chancel Choir has, also, been rewarding.

#### Goals for 2025 would be:

to increase membership and participation in the both the Chancel and Bell choirs.

Continue specialized maintenance on the pipe organ to preserve this historical instrument. Further work on inventory of choir music (both choral and bell music)

A special thank you needs to be extended to Pastor Mineo for his support and participation in the music program of St. John's. Beside enjoying his music, his willingness to do solos and sing in the choir have been a great example for members in our congregation.

I would, also, like to thank the people of St. John's for their support of the Church's music program. The members of the congregation who participate in the music program deserve the utmost praise for their tireless and selfless efforts in providing music for the glory of God. It is my hope that the St. John's Music Program will continue to glorify God and to enhance the worship experience of the congregation.

#### "Supply-Plus" Pastor's Report 2024

I invented the term: "Supply-Plus." It's not an official pastoral position and (to my knowledge) in any church documents. My official job description is "Supply Pastor," responsible for preaching and leading the congregation in worship. I retired from fulltime ministry in Ohio in November 2020. When my wife, Jo, and I returned to Pennsylvania to make our home here in May 2021, we had the wonderful experience of worshiping in the pew "like a normal person," as I like to put it, at Faith Lutheran Church in Erie. My calling as "Supply Pastor" began there on May 1, 2022, followed by supplying at twelve congregations in our synod.

My first weekend here at St. John's was June 4, 2023. That year, I was Supply Pastor here for 15 weekends and Christmas Eve. In the year 2024, I became more regular. I preached and led worship at St. John's for 45 Sundays in 2024, adding Ash Wednesday, the Wednesdays in Lent, Maundy Thursday, Good Friday, and Christmas Eve. I've also led Scout Sunday and the Blessing of Backpacks. I regularly attend our monthly "Worship & Music

Committee" meetings. As a new experience for me, I was introduced to and helped at our Homeless Shelter Ministry, "Our Neighbor's Place."

I've been blessed to participate in the Music Ministry of St. John's. I've also added regular music to our Saturday worship. It's a real joy and blessing for me to be invited to share music, including my original compositions, as part of my worship leadership here. I really appreciate and am thankful for these opportunities. We're had several conversations in 2024 concerning the development of "Youth Sunday," where our youth will serve as worship leaders. Our first "Youth Sunday" is scheduled for March 2, 2025.

In January of 2024 I taught a "First Communion Retreat" (which will become the "Affirmation of Communion Retreat" in 2025). In September, I taught a "Membership Class," which was titled, "What It Means To Be A Lutheran" for prospective members. As I always do, I invite everyone to attend as a refresher. We had a total of 32 in attendance, a record (by far) for my ministry! In 2024, we introduced quarterly Healing Services.

In January of 2024 we took down the Christmas decorations. We welcomed new members Janel Anderson & Molinda Kearns with a cake in the Narthex. First Communion was held for Charlotte "Charli" Alwens, Lillian "Lily" Alwens, and Ella Alwens along with a cake reception. Pastor Mineo installed the new Council Members.

We held soup suppers on Wednesday evening during Lent. These were held in the gym prior to the Wednesday services. We had approximately 50 people attend each week, including several Dufford Terrace residents. Six soups were provided each week, along with breads and desserts. Around 40 people attended the Wednesday service each week and a Healing service was held on one of the nights. Palm Fronds, Easter Lilies and Prim Roses were ordered for Palm Sunday and Easter. A Maundy Thursday Service, Palm Sunday, and 2 Good Friday Services were held in addition to the Wednesday night and Easter Services. Cake & juice were provided on Easter following the service.

The Bishop presided on August 11<sup>th</sup> and a potluck meal was served in the gym with chicken, salad and drinks provided by Worship & Music.

The choir robes were dry cleaned.

Blessing of Back Packs was held on August 25<sup>th</sup>. There were 8 youth and parents in attendance.

"What It Means To Be a Lutheran" was held on September 15<sup>th</sup>. Pastor Mineo offered this for current members and for those looking to join St. John's. There were over 30 people who attended! We had a potluck dinner with chicken, salad and drinks provided by Worship & Music. We welcomed 7 new members; Joyce Hersperger, Paul and Laura Horstman, Marek Klimczak, Christina Doupé, Andrea Walker and Mathieu "Matt" Sanders on September 22<sup>nd</sup>, followed with a cake reception in the Narthex.

#### **Social Ministry Annual Report 2024**

The Social Ministry Committee's mandate is to serve the needs of the community. We are grateful to the congregation and to the Magenau Fund for their support of our programs. Our committee has few meetings, and we welcome participation by congregational members in any of our events—one event or every event!

Our activities in brief:

Beginning in May there were planning meetings for all the coordinators hosting the Overflow Shelter, also called "Our Neighbors' Place." The coordinators did logistics to move the shelter for 2024-2025 to a permanent location at 450 E. 16<sup>th</sup> Street. St. John's coordinators are Diane and Bob Bestvina.

January 31 to February 14, 2024--Hosted the Overflow Shelter at St. John's, providing guests a warm place from 7:30 pm to 7:00 am, with a bed, snacks, hot beverages, showers, and foot care offered by a group of medical professionals

April 30—Attended the annual CROP Walk luncheon, receiving thanks for our participation

July 25—Cooked and served Sloppy Joe sandwiches and sides to more than 40 guests at Holy Trinity Lutheran Church community

August 6—Served homemade cookies and refreshments at the Lutheran House at Chautauqua

September 8—God's Work, Our Hands—We prepared a meal at Community Shelter Services.

September 29—CROP Walk for Hunger to meet the hunger needs of our community: our

walkers raised \$981.38!

July 21 and October 6--Sunday Supper at First Church of the Covenant –served hot meals to 114 guests and 14 volunteers of time and/or cupcakes

December—Generous donors provided 10 gift bags for students at Bethesda Lutheran Services in Meadville, along with items from their generic wish list

June, July, September, October, December— Served cookies and drinks at Gem City Band concerts

Project Dignity's mandate is to distribute personal care items and food (from the Second Harvest Food Bank inventory and supplemented with store shopping) to households within a designated area surrounding St. John's. Beginning in June, we altered our schedule to open the doors only in odd-numbered months, in consultation with Second Harvest Food Bank. Our food neighbors who needed food in months when we were closed were welcome to visit the Glenwood Methodist Food Bank. Our food neighbors continue to choose shelf-safe items, produce, and frozen foods from our shelves that best fit their households' needs. Every household receives personal care and hygiene items. We served 74 different households in 2024. As of the end of December we have required paperwork for 45 households falling within the Second Harvest boundaries to receive food from St. John's. Diane Bestvina, Project Dignity Coordinator and Food Pantry Representative with Second Harvest Food Bank is grateful for all the current volunteers, which include:

December 11<sup>th</sup> was a special, loved by all in attendance from 29 households, Christmas Party featuring a free tickets auction of 68 items and free giveaways of candy bags, calendars, tote bags, holiday décor, wrapping paper rolls, warm wearables, health items and a pump soap. A delicious meal was provided by Valerio's with dessert donated by our volunteers. Thank you to Janet Heubel, Carl Gehrlein and Brian Bestvina for joining our regular volunteers to help on this very special day.

#### **Dufford Terrace Report 2024**

To the Congregation of St. John's:

Opening in 1986 as an outreach of St. John's Lutheran Church, Dufford Terrace continues it's mission to serve Erie's aging population with quality, affordable apartments for those aged 62 and over. The Dufford Terrace Board of Directors, comprised of members of St. John's, oversees the management of the building, working along side and guiding our Property Managers – Glowacki Management Company.

The Dufford occupancy rate had not fully rebounded since the 2020 pandemic until this year when we renewed our social media efforts, updated our Facebook presence, and made up groud. Our occupancy rates are once again upward of 93%. We continue to rely on Roger Oleson and his work on making upgrades to our apartments. As the apartments open up, Roger completes any kitchen updates that were not recently renewed by adding new cabinets, countertops, and stoves. New flooring and carpeting are added throughout each apartment as needed and we update the bathrooms, adding new bathroom vanity cabinets and replacing any standard bathtubs with new walk-in showers.

A major consideration in 2024 were our elevators - we entertained a total refurbishment and/or replacement for the two Dufford elevators. After reviewing a bid and considering our needs, we moved forward with completing the repairs that initiated our bid considerations, as well as making some basic improvements that will put us in a better place for future refurbishments should we decide to move in that direction.

Dufford Tenant Jim Crosby continues to act as the Dufford Social Director, helping to plan activities, speakers, events, food trucks, and Bingo for the enjoyment of all of our residents. This past year we replaced the picnic tables in the outdoor pavilion and will be installing a new gas grill in the spring of 2025 for our tenants to use and enjoy. Our annual December Holiday Dinner and Bingo in the St. John's Gym was a success as many of our St. John's members joined the Dufford tenants for an enjoyable evening. Thank you to Barb Kulisek for once again handling all of the arrangements for that event, including her work with Sabella's catering, purchasing the Bingo supplies, and arranging to have cash prizes available for our winners.

As of November 30, 2024, and the writing of this report, Dufford Terrace had a net operating income of \$155,255 and occupancy was at 93%. The responsible management of, Dufford Terrace by the elected board has resulted in a healthy cash reserve and I would like to thank the entire board for all of the good work done this year. We continue to faithfully serve our senior residents and to implement projects that will benefit those for whom the building was meant to serve.
